Aviation Stakeholder Advisory Committee Oakland International Airport April 19, 2018

The Board of Port Commissioners adopted the Master Plan in March 2006, and the ASAC has continued meeting to give input on Master Plan implementation and other projects of interest at OAK. Welcome and introductions

Joshua Polston, Senior Project Manager, Planning and Development, and ASAC Facilitator, welcomed the group and noted that it was being recorded: everyone self-introduced.

Updates on Previously Discussed Projects, and new items

Airfield and Airspace Projects

Airport Perimeter Dike – Joshua Polston

- Completed 100% Design
- Bid will not go out until later this year
- In response to question regarding Horizon, JP noted that have moved away from horizon raising dike one foot, but not sure how long that will last

VALE Grant for GSE Electrification – Susan Fizzell, Project Manager, Planning & Development

- Scope of project centered on T1 and T2 has 25 existing charges
- Electrical work is progressing charges will be ready to use later this summer
- Will be placing 25 GSE charges around Terminal 1

Pavement Replacement – Joshua Polston

- Project is out to bid and work to be completed this summer and fall
- Also working on Twy Tango overlay 3-4 inches to rejuvenate pavement

 - Still was a good meeting because a lot of good ideas generated
 - Presentation will be on the website in the next few days
 - o The only "promise" was to initiate the study

Service Animal Relief Area Project – Lynne Madera, Project Manager, Planning & Development

- Under construction Notice to Proceed (NTP) as of 4/9
- Working on safety and security plan
- Construction should be complete early to mid-July
- Contractor is Bay Comm. Construction a local group

Terminal 1 Renovation & Retrofit Program Debrief – Susan Fizzell, Senior Project Manager, Planning & Development

- Project basically complete with only a few minor items remaining
- Structural Engineering won award for work done on project
- Can remove from agenda

T2 Roof Replacement

- 50,000 sf. Roof
- Wrapping up installation for interior protection
- Expect substantial completion by late June

Hotel RFP - Brandon Mark, Manager, Properties

- RFP released 4/27
- Construction not expected for a couple of years

Kaiser Air Hangar #2 Development – Brandon Mark

- Slowly moving through the process

- Carmen noted that CLASS reviewed project and received assurance it was just an automation update

- Alameda Nothing to report
- San Leandro Kathy Ornelas was unable to attend the meeting; however, asked Kathleen Livermore to report that the Shoreline Project has been delayed
 - Joshua noted that the S.L. Pollution Control Plant where sewage comes from is initiating a study to turn the plant into a kind of living wetland
 - Received Measure AA grant for \$600,000 to fund the study
 - o Kathy O. joined by phone to provide addition information on the Shoreline Project
