



**“Free Speech” Permit Application
to Leaflet, Picket, and/or Solicit at Oakland International Airport**

SECTION 1: BACKGROUND

Pursuant to the Rules and Regulations for Oakland International Airport (Port Ordinance No. 4579, as it may be amended; available on the Airport’s website) (“Rules & Regulations”), no Person shall Leaflet, Picket, Solicit, display signs, or otherwise attempt to communicate their views to other Airport users without submitting this “Free Speech” Permit Application (“Application”) and obtaining an approved Permit from the Assistant Director of the Oakland International Airport (“Airport”). The Airport will consider Applications on a case-by-case basis depending, in part, on the availability of designated locations for such requested activities.

The Airport is not a public forum for First Amendment Activities. Rather, the Airport is an air transportation facility for which the preservation and promotion of the health, security, and safety of all passengers, employees, and other patrons are of paramount importance. The Airport has a critical interest in ensuring that airport operations are not disrupted, maximizing passenger and pedestrian flow, and maintaining the high aesthetic and interior design qualities of the Airport.

This Application and any granted Permit are subject to all applicable provisions of the Rules & Regulations. Capitalized terms not otherwise defined in this Application shall have the meanings given them in the Rules & Regulations.

¹ “Leafleting” means the repetitive or continuous distribution of Non-Profit printed or written material.

² “Picketing” means the display of placard signs as part of a participating in a picket line or taking part in any labor or other form of demonstration, protest, or expression of Non-Profit speech.

³ “Soliciting” means the oral or written request for funds (including money, alms, property, and written pledges), signatures, or any thing of value to passers-by in a continuous and repetitive manner.

SECTION 4: GENERAL RULES

Applicant shall comply with all applicable requirements of the Rules & Regulations. The following contains only a summary of some of those requirements. Applicant (and any organization on whose behalf this Application is submitted) warrants that the activities under this proposed Permit is: (a) charitable, religious, or political in nature; or (b) not intended to derive or make a profit from the sale or exchange of goods or services.

All activities under the Permit shall be conducted:

1. Only during the times and in the areas allowed by a valid Permit.
2. In compliance with all applicable provisions of the Rules & Regulations, including (without limitation), Article 9 (Religious, Charitable, and Political Activities) and Section 3.3 (Assumption of Risk; Release; Indemnity), which states that the "exercise of the privilege of using the Airport and its facilities or any part thereof shall constitute the assumption of full responsibility and risk by any Person using the Airport and its facilities, and the agreement of such Person to Indemnify the Port, as such phrase is defined in Section 1.1."
3. In a peaceful and orderly manner, without physical harm, molestation, threat, or harassment of other persons, and without obscenities, violence, breach of the peace, property damage, or other unlawful conduct.
4. Without obstructing the public's use of the Airport and without hindering or interfering with the proper, safe, orderly, and efficient movement of passengers and users of the Airport or operation of the Airport and the activities conducted thereupon, and without interference with the constitutional rights of others.

The following activities are prohibited at the Terminal Complex:

1. Sale, distribution, or handing out of any type of food or drink.
2. Any attempt to pin, tie, or attach any flower or other symbol, insignia, article, or object to the clothing, luggage, or Vehicle of any Person without their consent.
3. Use of any musical instrument, noise-making device, or sound or voice amplifying apparatus, as well as any action that will reduce the effectiveness of the Airport public address system or that interferes with the Airport's business functions.
4. Intentionally leaving unattended any item that was intended for distribution.
5. Any conduct that misrepresents the identity of the person or organization performing the permitted activities.
